Detailed quotations invited from authorized / reegistered/ agencies/ eligible individuals to provide hired vehicle services to Goa State Wetland Authority (GSWA) office. The terms and conditions while submitting the quotation need to be adhered to are as follows:

- Applicant should have a valid driving license of the driver and hired vehicle formalities should be complete (if its yellow number plate vehicle)
- Applicant should have all the legal compliances such as up to date vehicle insurance, updated PUC etc. The same should be enclosed along with the quotation
- 3. The vehicle should be clean and hygienic on daily basis.
- 4. In absence of the vendor or due to unavoidable circumstances, the vendor should ensure the arrangement and availability of the back up vehicles of the same type.
- Vendor will provide vehicle as and when required by GSWA and GSBB, including on public holidays.
- 6. If the vendor agrees, they may provide his services for the period of two years based on mutual consent with GSWA/GSBB.
- In case of fuel hike the prices may be revised based on the basis of revisions by GTDC
 prices and with approval of the Chairperson, GSWA.
- 8. Undertaking to arrange the vehicle for outstation and validity of the rates may be given separately.
- 9. The bids will be submitted in the below format.
