At the onset, Dr. Pradip Sarmokadam, Member Secretary, Goa State Biodiversity Board extended a warm welcome to the members of the Technical and Grievance Committee.

Agenda 1: Familiarization with Wetland (Conservation and Management) Rules and Guidelines.

The Member Secretary, GSBB introduced the Members and gave a brief introduction to what is generally perceived as a Wetland as compared to what is defined as Wetland in the Wetland (Conservation and Management) Rules 2017. MS, GSBB presented a short power point presentation for the members on this topic. He specified the importance of Wetland in flood mitigation, supporting migratory birds etc. and briefed about the Ramsar Convention to which India is a signatory. He also emphasized on the concept of ecological character and Zone of influence. MS, GSBB also further explained how only the in-land waterbodies which are within the purview of other acts cannot be identified as Wetland and the definition excludes paddy fields and rivers.



The MS, GSBB also briefly expressed the role of the Technical and Grievance Committee. He stated that the role of the technical Committee would entail addressing the fine line as to which water body may be identified as Wetland according to the Wetland Rules 2017. He explained that CSIR-NIO has been appointed to prepare Brief Documents which shall be placed before the Technical Committee for review and incase of any grievance raised the Grievance Committee shall look into it and decide on the issues.

Agenda 2: Case Study of the first draft notified Wetland of Goa (Bondvol Lake)

The Committee Members expressed that it was difficult to address the issue virtually. It was unanimously decided that physical meeting would be appropriate for proper deliberation on this topic.

Agenda 3: Grievances received by GSWA based on draft notification of Bondvol Lake.

It was unanimously decided that physical meeting would be appropriate for proper deliberation on this topic.

Agenda 4: Any other matter with the permission of the chairperson.
