Initially all the grievants present brought to the notice of Grievance committee(GC) that Udden lake which is draft notified is in fact not Udden Lake but its called "Torla Lake" or "Talewada Lake". Sarpanch of Shiroda Village Panchayat and Chairperson of Biodiversity Management Committee Shiroda concurred with the submissions of the grievants and further informed GC that there is another waterbody nearby known as Udden lake, hence there is error in naming of the waterbody. The said waterbody which is wrongly named as Udden lake is maintained by the local community and water is used for Kulgars in the periphery of the waterbody.

<u>Conclusion:</u> GC decided to differ the draft notification of Udden lake and agreed that GSWA may differ the notification due to incorrect name and considering the assurance given by the locals to protect the draft notified Udden lake. It was decided that this opinion of GC may be referred to GSWA for final decision in this matter.
